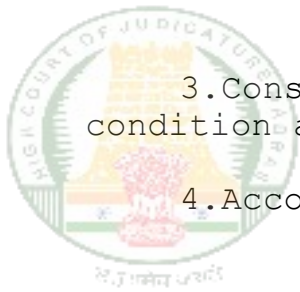
Prayer in CRL OP(MD). 5593/ 2022 :
