Since the petitioner herein had wrongly mentioned the name of the jurisdictional Court in this petition, he had filed another Criminal Original Petition in Crl.O.P.(MD).No.9333 of 2022 seeking for the same relief by mentioning the correct jurisdictional Court, in which, by order, dated 18.05.2022, a direction was given to consider the bail application of the petitioner.
