PRAYER :-

For Anticipatory Bail in Crime No. of 2022 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the offence punishable under Section 379(NP) of IPC, in Crime No.Not known of 2022, seeks anticipatory bail.

2.Today, when the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent Police submitted that the petition enquiry is pending against the petitioner.

3.The learned Counsel for the petitioner submitted that the respondent police is harassing the petitioner under the guise of enquiry.

4.Considering the facts and circumstances, the respondent police is directed to conduct the enquiry and if any prima facie



case made out against the petitioner, register the F.I.R or close the petition enquiry within a period of two weeks from the date of receipt of a copy of this order.

5. With the above directions, this criminal original petition is disposed of.
