3.The learned Government Advocate (Crl. Side) for the respondents 1 to 3 submitted that the latest complaint of the petitioner, dated 07.05.2022 will be considered within a period of eight weeks.

4.Considering the facts and circumstances of the case, the respondents police are directed to consider the petitioner's complaint dated 07.05.2022 and pass appropriate orders on its own merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order. It is made clear that no favourable direction is given in favour of the petitioner.

5.With the above direction, this Criminal Original Petition is disposed of.
