Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.RAMANATHAN R, Advocate for the petitioner and of M/S.M.AASHA, Government Advocate (Crl.Side) on behalf of the Respondent the court made the following order:-

This petition is filed to modify the condition imposed by this Court in Crl.O.P.(MD)No.8949 of 2022 on 11.05.2022.

2.The learned counsel appearing for the petitioner would submit that the petitioners 2 and 3 are aged about 89 & 77 years respectively and the first petitioner is a practising advocate of this Court. Hence, they are unable to comply the conditions imposed by this Court.

3.Considering the reasons stated in the affidavit filed in support of this petition, this Court is inclined to modify the condition to the effect that petitioners 2 and 3 are directed to



appear before the respondent police as and when required for interrogation. The first petitioner is directed to appear before the respondent police monthly once i.e., on the first working day of every English calendar month for a period of six months and thereafter as and when required for interrogation.
