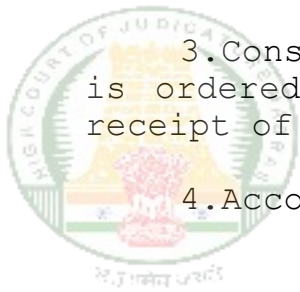
Prayer in CRL OP(MD) .No. 6412 of 2022:-
