Prayer: Contempt Petition filed under Section 11 of the Contempt of Courts Act, 1971 to punish the respondents for their willful, deliberate, disobedience of the order of this Court made in W.M.P. (MD)No.6780 in W.P.(MD)No.9003 of 2021, dated 01.06.2021.

Prayer in WP(MD) . 9003/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-15. To issue a Writ, Order or Direction in the nature of Writ of Certiorarified Mandamus, to call for the entire records relating to the impugned Termination Order dated 16.03.2021 on the file of the 4th respondent and quash the same and further directing the Respondents to reinstate the petitioner with continuity of service and to pass such further or other orders as this Honble Court may deem fit proper in the said circumstances of this case and thus render justice.



Prayer in WMP(MD) . 6780/ 2021 :

To stay all further proceedings of my impugned Termination Letter dated 16.03.2021 on the file of the 4th respondent pending disposal of the above WP and thus render justice.

The contempt petition is filed against the interim order passed by this Court on 01.06.2021.

2. An interim order of stay was granted till 27.07.2021. It is not made clear that whether the interim order granted was extended further. Under these circumstances, the contempt petition need not be kept pending unnecessarily.

3. When the interim order is not extended, the contempt petition cannot be kept pending. Thus, the petitioner is at liberty to pursue all the grounds during the final hearing of the writ petition.

4. Accordingly, the contempt petition stands closed.

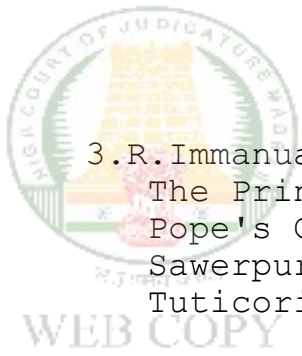
