Prayer in CRL MP(MD). 6733/ 2022 :

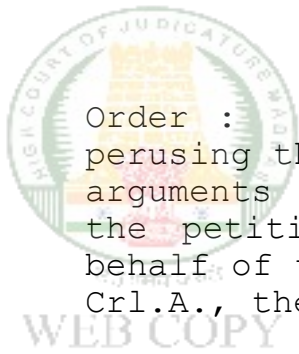
