The petition has been filed to relax the condition imposed on the petitioners in CRL OP(MD) No.8722 of 2022, dated 05.05.2022.

The learned counsel for the petitioners submitted that the petitioners have been complying with the condition imposed by this court in CRL OP(MD) No.8722 of 2022 on 05/05/2022 regularly, and he further submitted that the 1st petitioner has to appear for the paper valuation.
