PRAYER :-

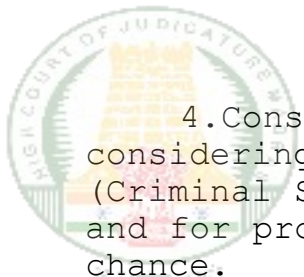
To extend the time granted in Crl.O.P. (MD) No. 2843 of 2022 dated 30.03.2022
