Alleging wilful disobedience of the order passed by this Court in W.P.(MD)No.4368 of 2022, this Contempt Petition has been filed.

2.The learned Counsel appearing for the petitioner submitted that this Court, by order dated 11.03.2022, in W.P(MD)No.4368 of 2022, directed the second respondent therein, to consider the complaint given by the petitioner, issue notice to both the parties and dispose of the case, within a period of two weeks, from the date of receipt of a copy of that order. But, the respondent police did not comply with the said order. Hence this petition has been filed.

3.The learned Additional Public Prosecutor submitted that based on the complaint lodged by the petitioner, enquiry has been conducted. Further, he stated that the matter is civil in nature and closed the same, on 15.06.2022.



4.Hence, this contempt petition stands closed.
