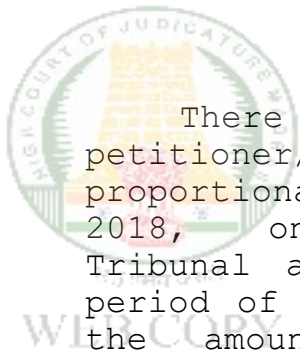

2. This Petition is allowed accordingly.
