ORDER

It is the case of the petitioner that there are encroachments in Sengudi Kanmai irrigation channel and Periyamelakandi Kanmai, Chinamelakkandi Kanmai, Kandikanmai and other irrigation channels in Vaniangudi Group, Muthur Vaniangudi Panchayat, Kalaiyarkovil Union, Sivagangai District, for removal of which, the Public Interest Litigation has been filed.

2.Heard the learned counsel for the petitioner.

3.It is seen that the petitioner has given a representation dated 20.05.2022, which is bereft of even minimum particulars. We do not find any substance at all in the representation or in the allegations of the petitioner for entertaining this Public Interest Litigation. Hence, this writ petition is dismissed. No costs.
