2.In pursuance of the order of this Court, dated 27.06.2022, the learned Judicial Magistrate No.II, Fast Track Court (Magistrate Level), Madurai, has sent a letter, dated 04.07.2022, stating that the petitioner appeared before that Court daily at 10.30 am from 27.05.2022 to till 01.07.2022.



3. There is no representation for the respondent. Counsel for the petitioner is present.

4. Considering the above, this Court is inclined to modify the condition to the effect that the petitioner is directed appear before the concerned Court once in a month i.e., on the first working day of every English calendar month at 10.30 a.m until further orders.
