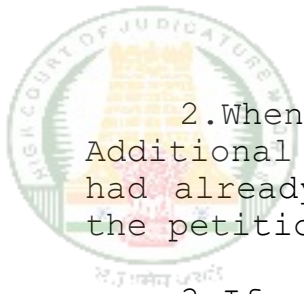

ORDER

The criminal original petition has been filed seeking to direct the first respondent to direct the third respondent to incorporate the provisions of law under Section 465, 468, 466 and 420 of IPC and Section 4 of the Muslim Women (Protection of Rights on Marriage) Act, 2019 in FIR.No.14/2021, by considering the petitioner's representation, dated 01.07.2021.



2.When the matter is taken up for hearing, the learned Additional Public Prosecutor submitted that the respondent police had already commenced the investigation on the complaint lodged by the petitioner and about to complete the same.
