3.The order impugned in this Writ Petition is only a show cause notice pursuant to a petition filed by the respondents under Section 14 of the SARFAESI Act. Since the order impugned in this Writ



Petition is only a show cause notice and the petitioner has ample opportunity to putforth her case, this Court is not inclined to interfere with the statutory proceedings initiated in accordance with law.

4.Hence, this Writ Petition is dismissed. However, it is open to the petitioner to challenge the final order, that may be passed by the learned Chief Judicial Magistrate, Theni in the manner known to law. No costs. Consequently, connected miscellaneous petition is closed.
