This petition has been filed to relax the condition imposed on the petitioner in Crl.O.P.(MD)No.8931 of 2021 on 06.05.2022.

2. Objection was raised by the learned Government Advocate (Crl.Side) to the effect that the petitioner gave a complaint before the concerned jurisdictional police stating that he has fear about the life because of threat. He would further submit that it is a case of retaliation murder and more than 12 previous cases are pending against the petitioner.

3.In view of the submission made by the learned Government Advocate (Crl.Side), I find no merit in this petition.



4. Accordingly, this Criminal Miscellaneous Petition is dismissed. The petitioner is directed to comply the condition passed by this Court in Crl.OP(MD)No.8931 of 2022 dated 06.05.2022 strictly.
