3. Recording the same, this Criminal Original Petition is dismissed.

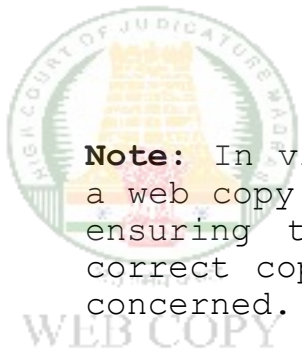
