O R D E R

This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus to direct the respondents to grant permission and protection for Adal Padal Programme to be held on 08.06.2022 between 06.00 P.M to 11.00 P.M in Arulmigu Sri Maga Ganapathy, Sri Selva Mariamman and Madurai Veeran Swamy, Kottadhur Village, Kottathur Post, Duraiyur Taluk, Trichy District by considering the petitioner's representation dated 01.06.2022.

2.Mr.M.Sakthi Kumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage



3.The learned counsel appearing for the petitioner submitted that Kumbabisegam festival for the temple, by name, Arulmigu Sri Maga Ganapathy, Sri Selva Mariamman and Madurai Veeran Swamy situated at Kottadhur Village, Kottathur Post, Duraiyur Taluk, Trichy District is going to be held on 08.06.2022. Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving a representation dated 01.06.2022. But, the second respondent has not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

4.The learned Government Advocate (criminal side) appearing for the respondent police would submit that the second respondent has received the representation of the petitioner and the same is pending for consideration.

5.I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (criminal side) appearing for the respondent police.

6.It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to consider the representation of the petitioner, dated 01.06.2022 and pass suitable orders based on the above said circular.

7. With the above direction, this writ petition is disposed of. No costs.
