2.The limited prayer sought for in the present Writ Petition is for a direction to the first respondent to dispose of the appeal filed by the petitioner, dated 15.03.2007 seeking re-fixation of the petitioner's seniority by way of including him in the 1996 Assistant Panel in the appropriate place.

3.Since the appeal is still pending, it would be appropriate to direct the first respondent to dispose it of expeditiously, within the stipulated time.

4.In view of the above observations, there shall be a direction to the first respondent to dispose of the appeal filed by the petitioner, dated 15.03.2007, if not already disposed of, as expeditiously as possible, in any event, within a period of three



(3) months from the date of receipt of a copy of this order.

5. With the above direction, the Writ Petition stands disposed of. No costs.
