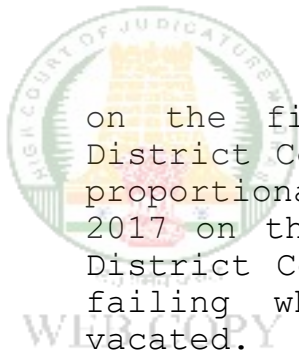
Prayer in CMA(MD) . 712/ 2022 :
