This petition is filed to direct the second respondent to file a final report in Crime No.85 of 2014 on the file of the 2nd respondent within a time period stipulated by this Court.

2.The petitioner is the defacto complainant in Crime No.85 of 2014, which was registered against the accused persons, for the offences punishable under Sections 406, 420 of IPC and R/w Section 4 of Tamil Nadu Prohibition of Charging Exorbitant Interest and Ordinance Act, 2003.
