The fifth respondent has now informed the petitioner vide letter dated 13.12.2022 that only a sum of Rs.12,427/- has been received towards the petitioner's account. The fifth respondent is directed to pay the said amount to the petitioner. The fifth respondent is also directed to send a revised proposal to the third respondent. The third respondent shall process the same and take further action on merits and in accordance with law. The entire exercise shall be completed within a period of eight weeks from the date of receipt of a copy of this order.

3.The writ petition is disposed of accordingly. No costs.
