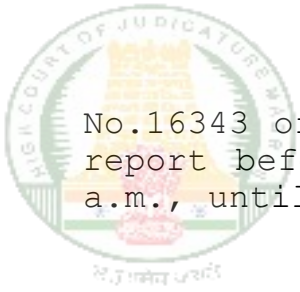
This petition has been filed to relax the condition imposed on the petitioner in Crl.O.P.(MD)No.16343 of 2021 on 28.10.2021.
