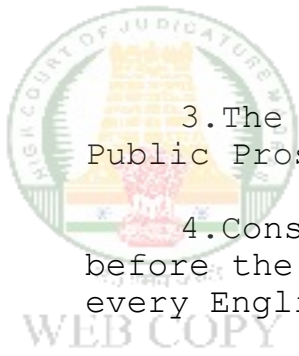
PRAYER IN CRL A(MD) No.290 of 2022:
