PRAYER IN A.S(MD)No.199 of 2009:

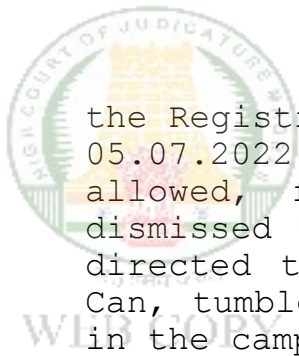
