This Writ Petition has been filed for issuance of a Writ of Mandamus, directing the respondents 1 and 2 to remove the encroachments made by the respondents 3 to 5 in Survey Nos.552/7 and 552/4 at Kulasekaran Kottai Village, T.Vadipatti Post and Taluk, Madurai District, on the basis of the petitioner's representation dated 26.10.2018.

2. Today, when the matter was taken up for hearing, it is reported that the petitioner is no more. However, the learned Government Advocate appearing for the respondents 1 and 2 submitted that necessary action would be taken for the removal of encroachments, if any, as alleged by the petitioner.
