Prayer in Habeas Corpus Petition(MD) No. . 391/ 2022 :

Petition praying that in the circumstances stated therein and in the affidavit filed therewith, the High Court will be pleased to issue a Writ of Habeas Corpus, to Detention Order of the 2nd respondent in Detention Order No.4 /2022 dated 26.1.2022 and Quash the same and direct the Respondents to produce the body or person of the detenu by name Gnana Praksh@ Prakash, S/o.Mariya Arockiadas, aged about 34 years, now confining as 'Goonda' at Madurai Central Prison before this Hon'ble Court and set petitioner at liberty forthwith.

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.ALAGUMANI R, Advocate for the petitioner and of MR.S.RAVI, Additional Public Prosecutor on behalf of the Respondents, the court made the following order:-

This Criminal Miscellaneous Petition has been filed for a direction to the respondents to shift the detenu, viz., Gnana Prakash @ Prakash, from the Central Prison, Madurai to the Government Rajaji Hospital, Madurai, for proper treatment.

2.When the matter was taken up for hearing, Mr.S.Ravi, learned Additional Public Prosecutor who accepts notice on behalf of the respondents produced a communication dated 22.06.2022 from the Medical Officer, Central Prison Hospital, Madurai, wherein it is stated that the said detenu has been shifted to Government Rajaji Hospital, Madurai, and is under treatment there.

3.Recording the same, this Criminal Miscellaneous Petition is closed.
