PRAYER IN CRL A(MD)No. 48 of 2022:

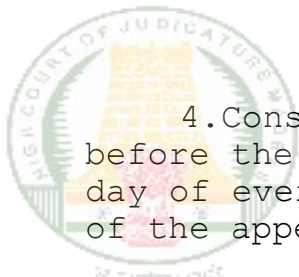
