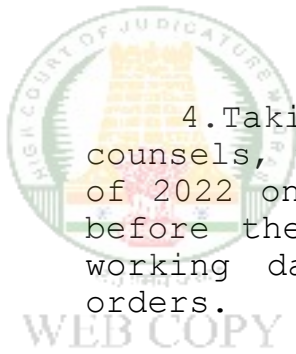

This petition has been filed to relax the condition imposed on the petitioner in Crl.O.P.(MD)No.9109 of 2022 on 18.05.2022.

2. The learned counsel for the petitioners submitted that the petitioner has been complying with the condition regularly and he prayed for relaxation of the said condition.

3.The learned Government Advocate (Crl. Side) submitted that the petitioner has complied with the condition regularly and investigation is still pending.
