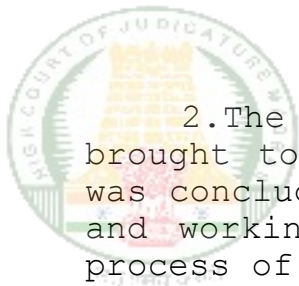

The writ on hand has been instituted challenging the Recruitment Notification published in daily news paper "Dina Thanthi" dated 31.01.2019, to fill up the post of Physical Education Director in the third respondent private aided school.



2.The learned counsel appearing for the third respondent brought to the notice of this Court that the process of selection was concluded and the eligible candidates had already been appointed and working. However, the petitioner has not participated in the process of selection.

3.The learned counsel for the petitioner states that the appointment is yet to be approved by the competent educational authority.

4.Under these circumstances, it is left open to the writ petitioner to redress his remedy in a proper manner, as known to law.

5.With this liberty, this Writ Petition stands disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
