Further stated that enquiry is pending and the respondent police is ready to complete the enquiry within a period of one week.

3. Recording the same, the respondent police is hereby directed to conclude the enquiry within a period of one week from the date of receipt of a copy of this order and take suitable action.

4. With the above direction, this writ petition stands disposed of. No costs.
