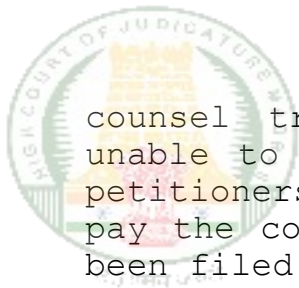
Prayer in CRL OP(MD)No.7526 of 2022:-
