### ORDER

Based on that, the respondent police frequently asked the petitioners to appear before the respondent police station. Hence, this petition has been filed.



3.The learned Government Advocate (Cr1.Side) submitted that the respondent police conducted an enquiry on the basis of the complaint received from the complainant, advised the parties to approach civil Court for getting appropriate remedy and closed the same, on 21.03.2022. He further stated that hereafter, the respondent police will not call the petitioners in this connection.

4.Recording the same, this criminal original petition stands disposed of.
