Prayer in WP(MD) . 9886 of 2022 :

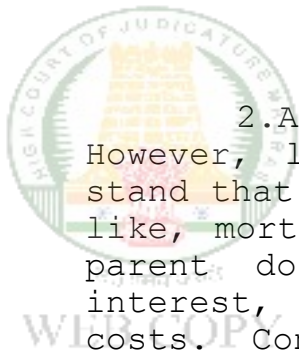

JUDGMENT

Considering the peculiar facts in this case that the father has executed a settlement deed in favour of his son and the Sub Registrar has refused to register the document without parent document being filed, the learned Additional Advocate General appearing for the appellant seeks permission of this Court to withdraw this appeal. Permission is granted.



2. Accordingly, this Writ Appeal is dismissed as withdrawn. However, liberty is preserved for the appellant to maintain the stand that the Register can refuse to register any other conveyance, like, mortgage, sale or lease by insisting to produce the original parent documents to avoid fraudulent registrations in public interest, which will be examined in details by this Court. No costs. Consequently, connected miscellaneous petition is closed.
