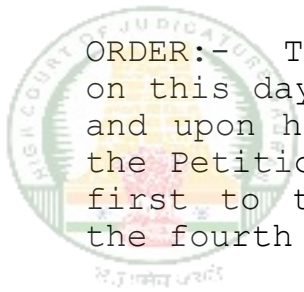

Prayer in Crl.MP(MD).NO.7048 of 2022 :-

This Criminal Miscellaneous Petition is filed under section 482 Cr.P.C to extend the time period of payment to 4th respondent in further 3 months as directed in Main Petition in Crl.O.P.(MD) No. 18098 of 2021 dt.21/12/2021 by this Honourable Court and thus render justice.

Prayer in Crl O.P(MD).No.18098 of2021:

This Criminal Original Petition is filed under Section 482 Cr.P.C to directing the 1st respondent to withdraw the Look Out Circular/Notice issued against the petitioner in connection with the case in Crime No.14 of 2019 on the file of the second respondent and consequently, to direct the 1st respondent to intimate the same to the immigration officer and thus render justice.

3 In view of the same, time already granted by this Court vide order dated 21.12.2021 is extended for a period of 3-months from the date of receipt of a copy of this order, failing which the order shall stand dismissed automatically without any further reference to this court.

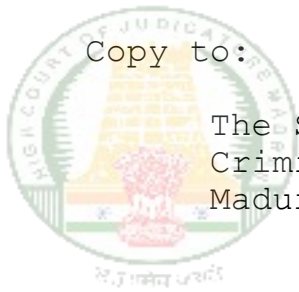
