2.It is seen from the records that this Court, vide order dated 10.08.2022, directed the learned Principal District Judge, Dindigul to dispose of the petition in GWOP.No.37 of 2021 within a period of six months from the date of receipt of copy of that order and subsequently, at the request of the learned Principal District Judge, Dindigul, three months further time was granted vide order dated 15.06.2023.
