Based upon the subsequent complaint, now, summon has been issued to the petitioner to appear before the respondent police by the fourth respondent.

3. Let the third respondent undertake the enquiry on the complaint given by the petitioner.

4. With the above said direction, this Writ Petition is disposed of. No costs.
