place. Further, till now, the petitioners are complying the condition without fail. Hence, he seeks above said modification.

4.The petitioner may approach the concerned Court for modification by setting out the facts and circumstances. If it is rejected, then he may approach this Court.

5.With the above said liberty, this Criminal Original Petition is disposed of.
