3.Post the matter on 14.09.2022, for reporting compliance.

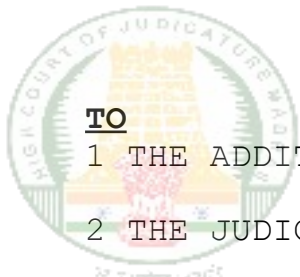
