3.The learned Government Advocate (Crl.side) for the respondent submitted that the petitioner has been complying with the conditions regularly and the investigation is still pending.

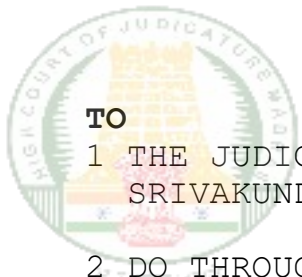
