2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondent.

3.The learned counsel appearing for the petitioner submitted that the respondent Police has registered a case against the petitioner in Crime No.226 of 2019 on 19.06.2019 for the offences under Sections 8(c), r/w 20 (b) (ii) (A) of NDPS Act. After the investigation, the respondent police has filed a final report before the learned Judicial Magistrate, Nilakottai and the same has been taken on file in S.T.C.No.4 of 2022. He further submitted that the petitioner is not connected with the case. Due to pendency of this case, the petitioner is unable to get appropriate job.
