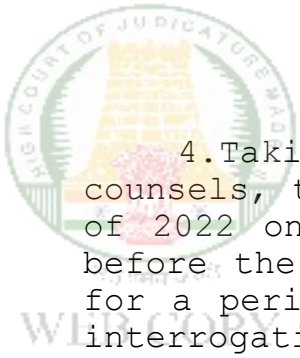

This petition has been filed to modify the condition imposed on the petitioner in Crl.O.P.(MD)No.9673 of 2022 on 01.06.2022.

2. The learned counsel for the petitioner submitted that the petitioner is residing at Dindigul District and the present case is pending before the Kadambur Police Station, Thoothukudi District. Hence, he could not travel from Dindigul to Thoothukudi District and report before the respondent police daily and he prayed for modification of the said condition.

3.The learned Government Advocate(Crl.side) submitted that the investigation is still pending.
