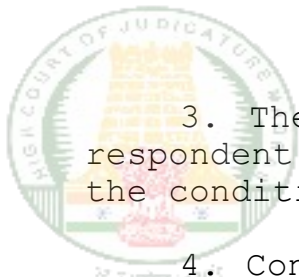
Prayer in Crl.A(MD)No.453 of 2021:
