2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the first respondent.

3.The learned counsel appearing for the petitioner submitted that the first respondent Police has registered a case against the petitioner in Crime No.864 of 2015 for the offences under Sections 294(b), 323, 324 and 506(ii) of IPC. After the investigation, the respondent police has filed a final report before the learned Judicial Magistrate, Rajapalayam and the same has been taken on file in C.C.No.205 of 2016.
