4.With the above direction, this Criminal Original Petition is disposed of.

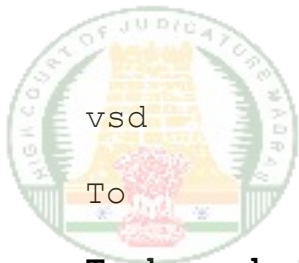
