4. In this view of the matter, the seventh respondent is restrained from operating any brick kiln without getting proper permission from the second respondent. The second respondent before passing any final order on the seventh respondent's application shall put the petitioner on notice.

5. The writ petition is disposed of accordingly. No costs.
