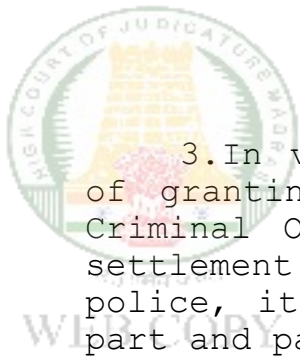
PRAYER :-
