Prayer in CRL A(MD) No.227 of 2022:

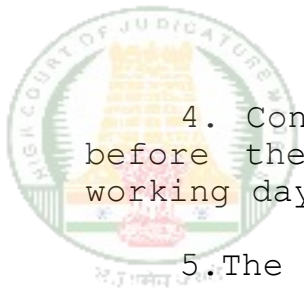
