### **ORDER**

After enquiry, both the parties gave a statement that they have not involved any problem with regard to the land and not to interfere with each other. Hence, the complaint has been closed.

4. Recording the same, this Criminal Original Petition is closed with liberty to the petitioner to approach the Civil Court for appropriate relief.
